

Resolution No. 266

Supervisor JOHNSON AND GENDRON offered the following Resolution and moved its adoption:

**RESOLUTION ADOPTING STANDARD WORKDAY AND
RETIREMENT REPORTING CREDIT FOR ELECTED OFFICIALS**

WHEREAS, the NYS Retirement System changed the reporting requirements for elected and appointed officials who are members of the Retirement System but do not use a timekeeping system; and

WHEREAS, the Board of Supervisors must adopt a standard workday and retirement reporting credit for said elected and appointed officials after the first 180 days of taking office or whenever a newly elected or appointed office is established; and

WHEREAS, pursuant to said regulations, Fulton County elected and appointed officials have submitted three-month activity logs to the Personnel Department, in order to determine the number of days per month to be reported to the Retirement System; now, therefore be it

RESOLVED, That the Board of Supervisors hereby establishes standard workdays for elected officials and will report the days worked to the New York State and Local Employees' Retirement System, based on the record of activities maintained and submitted by the officials to the Fulton County Personnel Director, as follows:
