Chairman Ottuso called the meeting to order at 1:00 p.m. with Supervisor Johnson absent upon roll call. Following the Pledge of Allegiance, Chairman Ottuso asked if there was anyone from the public who wished to address the Board.

John Kane, West Bush Road, Gloversville: – Mr. Kane advised that he was a member of “Solidarity for a Better County Government”. He noted at the Organizational Board meeting on January 2, 2015 appointments to the Board Committees were made. He stated that some “public TV host” recently made an observation about the annual Committee appointments and claimed that no resolution was done for these appointments. When Chairman Ottuso was questioned after the meeting, he stated that appointments and decisions made by the Board are determined based on what is the best for the region.

UPDATES FROM STANDING COMMITTEES

Economic Development and Environment: Chairman Potter advised that the Committee met this morning to hear a presentation by Solar Liberty regarding the proposed solar project at the Landfill that would save money for county departments.

Personnel: Supervisor Callery advised that a meeting was held with the CSEA General Unit to begin negotiations. He advised that proposals were exchanged and the next negotiation session will be held in March.

REPORTS OF SPECIAL COMMITTEES

Inter-County Legislative Committee of the Adirondacks: Supervisor MacVean advised that the first meeting of the year was held on January 22. Mark Lavigne from NYSAC did most of the talking. She stated that the representatives at the meeting urged all counties to sponsor a resolution stating opposition to the so-called economic “Hunger Games”, which is related to the Economic Revitalization Competition that is being proposed by the Governor. She also referenced changes to the STAR program emanating from the Governor’s Tax Credit proposal.

Soil and Water Conservation District Board: Supervisor Lauria advised that the first meeting of the year was held on January 20. He advised that there is a lot of work going on. He referenced McNamara’s pond, work at the Ephratah Rod and Gun Club and the Town of Broadalbin Youth Commission. He also stated that there are four (4) bridges that need work in the City of Johnstown. He further noted that the DEC grants have been approved for mapping and assessing of streams and culverts. He stated that the District will be receiving \$50,000.00 per year over the next three years.

CHAIRMAN'S REPORT

Chairman Ottuso stated that his first month has been interesting. He attended the NYSAC Conference last week and found it to be very interesting and informative. He recommended that Supervisors take the emergency management training that he attended, especially town Supervisors. He also noted that he met Governor Cuomo and hand-delivered a letter to him regarding the economic benefit of Medicaid takeover upstate.

RESOLUTIONS (TITLES ATTACHED)

No. 41 (Resolution authorizing Transfer of Title of 7 Elm Street (SBL 134.18-34-9) to the City of Gloversville for Neighborhood Rehabilitation): Supervisor Callery stated that he thought the Gloversville City Attorney had pending litigation against the former owners for removing the stained glass windows and damage to the building. He asked if this is the case, will the County be able to recoup any of the delinquent taxes due to the County. Mr. Brott stated there was litigation, but he is not sure of the status at this time. He also stated that he thinks the litigation was related to fines imposed by the Code Enforcement Officer, not for damage to the building.

(Supervisor Johnson arrived at 1:25 p.m.)

A motion was offered by Supervisor Fagan, seconded by Supervisor Callery and unanimously carried, to waive the Rules of Order to take Action on Late Resolutions 74-76.

OLD BUSINESS

Chairman Ottuso advised that he will be doing a "Quote of the Month" contest and that January's quote was from George Washington. He stated that correct answer sheets will be placed "into a hat" and a final winner will be drawn to break the tie. He will be providing the winner with a \$20 gift certificate to a local business.

Chairman Ottuso then advised Mr. Kane and all present that he did choose the Standing Committee assignments this year. He stated that he "mixed them up" to give everyone a chance to experience different committees and Chairmanships. Chairman Ottuso also thanked the Board of Supervisors for their dedication and recognizes everything that they do for the betterment of the community.

NEW BUSINESS

Supervisor Lauria stated that Governor Cuomo needs to reestablish the Moreland Commission because what is going on in Albany related to unethical actions is a disgrace.

Supervisor Fagan referenced the so-called "Hunger Games" mentioned earlier, which is a competition for economic development money being implemented by Governor Cuomo. He stated that Fulton County should go on record that they are concerned with the disbursement of the \$1.5 billion to only three (3) of the seven (7) regions by "competition". He stated that all of New York needs to be "spurred", not just two or three pockets.

Mr. Stead stated that at the request of Supervisor MacVean, he planned to prepare an Agenda Item for the next Economic Development and Environment Committee meeting. Supervisor Fagan stated that is good but he also suggested that a letter be sent to Governor Cuomo from Chairman Ottuso expressing Fulton County's concern for the currently proposed approach.

Utilizing the \$1.5 billion and dividing it according to population for counties would be a huge economic boost. Supervisor Fagan suggested putting it towards Medicaid relief.

Chairman Ottuso stated that all counties have this same concern and if the \$1.5 billion was applied to the Medicaid mandate, it would reduce property taxes by 52 percent. It was noted that Governor Cuomo realizes that upstate New York has been forgotten about and he is trying to do things to improve this.

Supervisor Johnson stated that he is also concerned about how this money will be distributed and asked what our state representatives are doing about it. Why aren't they complaining about this? He asked rhetorically if, "a bug should be put in their ear".

Supervisor Groff stated that he spoke to Senator Farley and Assemblyman Butler about this and they responded that they are opposed to the competition for the economic development money. Supervisor Groff stated if this money was divided equally amongst all counties, it would equal about \$23 million per county.

Supervisor Greene stated that he is not sure if it should be reinstatement of the Moreland Commission or if we should wait and see how the U.S. attorney handles Assemblyman Silver's case, but it is pretty obvious that ethically things are broken in Albany and they have been for some time. He stated that it will be interesting to see how far this will go.

Supervisor Young stated that he believes one of the resolutions that was voted on at the NYSAC Conference was expressing opposition to the so-called economic "Hunger Games".

Mr. Stead stated that the State also wants to make the tax freeze on municipalities permanent and this is very distressing.

Supervisor Fagan made a motion to have Chairman Ottuso send a letter to Governor Cuomo expressing the County's concern regarding the proposed formula for the Economic Revitalization Competition, seconded by Supervisor Waldron and unanimously carried.

Chairman Ottuso called for a recess at 1:41 p.m. to await Congresswoman Elise Stefanik's arrival.

Chairman Ottuso called the meeting back to order at 1:53 p.m.

Congresswoman Elise Stefanik arrived at the meeting at 1:53 p.m. Chairman Ottuso introduced Ms. Stefanik and noted that she is the youngest woman ever to be voted into Congress.

Congresswoman Stefanik thanked everyone for allowing her to stop in today. She specifically thanked Chairman Ottuso, Mr. Stead and Supervisor Potter for arranging the visit. She stated that she has been in office for just over a month and wanted to provide an update on what is going on in Washington. She stated that she has hit the ground running as far as her constituents' concerns. She will have a mobile district office later this spring. She asked everyone to please come to the office with any questions or concerns. She stated that "my offices are your offices". She said that she wants to make sure that her constituents are updated with what is happening in Washington and that their concerns are being addressed. Ms. Stefanik stated that her number one goal on every piece of legislation is to make sure that she is improving the lives of the residents of the 21st Congressional District.

Ms. Stefanik stated that the Keystone Pipeline is a bipartisan energy project that will create 42,000 jobs and lower energy costs. She stated that this has passed on a bipartisan basis in the House and Senate and it will go to the President in the coming weeks.

Ms. Stefanik also stated that she is promoting Job Creation and Reducing Small Business Costs Acts. Her goal is to create jobs and ensure that small businesses have the ability to grow. She noted that they recently passed the Human Trafficking Prevention and Intervention Recovery Act. This Act ensures that law enforcement agencies have the best information to prevent and deter these crimes.

Ms. Stefanik also advised that the Clay Hunt Suicide Prevention for American Veterans Act is also being enacted. She stated that over thirty (30) pieces of legislation have been passed since the beginning of the year.

Ms. Stefanik reported that she has been appointed to the House Armed Services Committee and Committee on Education in the Workforce. She is also Vice Chairman of the Subcommittee on Readiness which focuses on Department of Defense spending and protecting and strengthening Fort Drum. This will give her the ability to undo the damaging effects of the sequester, which is devastating our nation's military.

Ms. Stefanik stated that she wants to make sure that her office brings in a new era of transparency in government. Every vote taken since taking office has been posted on her official website and Facebook page. She will continue to do that as long as she serves in office. She hopes other people follow this lead. She also has a weekly e-newsletter to keep constituents updated about pending legislation and various meetings.

Ms. Stefanik stated that she would love to take any questions anyone may have. She stated that it has been a privilege serving her constituents and she is working her hardest to bring energy, transparency and smart common sense solutions to this district.

Supervisor Howard asked Ms. Stefanik about her position on the amnesty for illegal aliens issue. She stated that she does not support amnesty and that legal immigration reform is needed. She stated that she will probably see a number of issues relative to this in the next year. She stated that agriculture workers are relying on an out-of-date aging immigration system.

Supervisor Young asked if Ms. Stefanik will be providing an office in Gloversville. She stated that she is concentrating on a mobile district office to handle this area. She stated that she will be spending a lot of time in Fulton County as well as the other 12 counties in the 21st District. She stated that she spends more time in Fulton County than her predecessor.

Supervisor Fagan asked Ms. Stefanik if there is any progress on repealing the Affordable Health Care Act. She stated that a vote was taken last week on this and she believes it is a responsibility of leadership and members of Congress to put forth a replacement package. She stated that a repeal was discussed, but also instructed the Committees in the House to have a replacement plan with the goals of lowering costs to make it more affordable, increase quality and increase access to medical care. She stated that they are in the process of formulating a replacement plan and hopefully will see that later this year. Supervisor Fagan stated that this Act has put a burden on businesses especially with regards to the 40 hour work week. She stated that a 40-hour work week has been addressed in Congress and hopefully the President will approve this. She stated that the medical device tax repeal is also important. She stated that manufacturers have struggled under this tax. It should not be a manufacturers responsibility to pay for a broken health care system.

Mr. Stead stated that Ms. Stefanik ran on the fact that she would like to make the tax code simpler and easier. Ms. Stefanik stated that Congress is going to try and tackle fundamental tax reform. It wants to work with the White House and it needs to focus on corporate and individual tax reform. She stated that it is her goal to work on this in the next two years. She stated that hopefully the administration is willing to work with Congress on this. She is still committed to this and is making sure this is a priority in Congress.

Mr. Stead stated that he hopes Ms. Stefanik is not in favor of increasing the fuel tax. She stated that she does not share the belief that raising taxes encourages economic growth. If it is raised, it would be a burden on rural communities like ours. When it comes to infrastructure, there needs to be a long term infrastructure investment plan.

Chairman Ottuso thanked Ms. Stefanik for coming today and updating the Board as to what is happening in Washington.

Upon a motion by Supervisor Callery, seconded by Supervisor Young and unanimously carried, the Board adjourned at 2:07 p.m.
