THIRD DAY OF ANNUAL SESSION

In the absence of Chairman of the Board Ottuso, Vice-Chairman Potter called the meeting to order at 1:03 p.m. with Supervisors Born, Greene, Johnson, MacVean and Ottuso absent upon roll call. Following the Pledge of Allegiance, Vice-Chairman Potter asked if there was anyone from the public who wished to address the Board on subjects other than the proposed 2016 Budget. There was no one present who wished to speak.

COMMUNICATIONS

Mr. Stead, Administrative Officer, explained that the Board of Supervisors received a letter from the Northville Falcons Helpers 4-H Club and Vice-Chairman Potter will read it when he gives the Chairman's Report.

CHAIRMAN'S REPORT

Acting Chairman Potter read a letter from Jennifer Donovan, Club Leader, for the Northville Falcons Helpers 4-H Club. Mr. Potter read the letter thanking the Board for reconsidering and allocating the sum of \$20,000.00 to Cooperative Extension for 2016. Mr. Potter explained that letters and pictures were enclosed and they were placed in the Board break room on the bulletin board.

RESOLUTIONS

No. 426 (Resolution Approving a "SMART Waters" Inter-Municipal Agreement Between the County of Fulton, City of Gloversville Common Council, and the Gloversville Board of Water Commissioners): Supervisor Young commended the Fulton County Attorney and the City of Gloversville Attorney for all their hard work in putting together the Agreement and the very thorough job they accomplished. He added that "It will be a great agreement for the City of Gloversville and Fulton County".

Supervisor Fagan explained to Board members that he was a part of the team that negotiated "SMART Waters" and he appreciated all the time and effort everyone put into it and also thanked City of Gloversville officials. He further explained that this was one step of many more to be done to build Fulton County's future.

No. 432 (Resolution Accepting Report on Town and City Accounts): Supervisor Callery questioned why the "credit" amount to the City of Gloversville was so high. Ms. Kuntzsch, Budget Director, explained that she would have to check with the Treasurer for that answer.

Mr. Stead, Administrative Officer, recommended that Resolutions 437 and 438 be laid aside until the public hearing and final budget deliberations are completed.

Chairman of Finance Argotsinger then proceeded to the dais. Chairman Argotsinger then asked Ms. Kuntzsch, Budget Director/County Auditor, to conduct the 2016 Budget Review.

Ms. Kuntzsch explained that after speaking with Perry Lovell, Director of Information Services, it was decided to reduce the telephone accounts for all County departments resulting from a new phone system installed for next year.

Ms. Kuntzsch further explained that a "Pub Works Server" can be purchased this year for the Highways and Facilities Department at a 50 percent discount, so this was removed from the 2016 Budget.

Ms. Kuntzsch continued that the new levy would be \$27,775,897.00 with a \$10.21 average county tax rate. A decrease of .62 cents per thousand from last year.

Supervisor Waldron made a motion to approve the budget adjustments as presented by Ms. Kuntzsch, seconded by Supervisor Groff and unanimously carried.

Supervisor Fagan commented that the Revenue Sharing Agreement with Montgomery County was a long time coming and it will help the local economy grow.

Acting Chairman Potter called for a recess of the Board meeting at 1:30 p.m.

Acting Chairman Potter reconvened the Board meeting at 2:00 p.m.

Acting Chairman Potter opened the Public Hearing on the 2016 Tentative Budget at 2:00 p.m. for the County of Fulton for fiscal year beginning January 1, 2016. There being no public speakers who wished to address the Board, Acting Chairman Potter announced that he would keep the public hearing open for a portion of the Board Meeting.

Supervisor Fagan advised that after the Finance meeting that occurred earlier in the day, he will be suggesting applying \$200,000.00 more in Fund Balance to next year's budget. He further advised that the Budget Director had explained at the Finance meeting that two (2) companies had fulfilled their PILOT Agreements, so about \$40,000.00 in PILOT revenue must be reduced.

Mr. Stead explained what a PILOT was. In this example, as businesses in the community fulfilled their commitment payments in lieu of property taxes, the businesses will be paying full taxes in 2016.

Ms. Kuntzsch advised that if another \$200,000.00 is applied from Fund Balance, 2016 Budget appropriations would be \$27,615,597.00 with a \$10.15 average county tax rate, which is a 6.3 percent decrease. Fulton County would be \$296,578.00 under the state-mandated Tax Cap.

Acting Chairman Potter asked again if there were any members of the public who wished to make comments regarding the Tentative Budget for the County of Fulton for fiscal year beginning January 1, 2016. There being no public speakers, Acting Chairman Potter closed the Public Hearing at 2:10 p.m.

Supervisor Young advised that taking additional funds from the Fund Balance is not necessary because it is the "public's savings account" and the County does not need to apply more.

Supervisor Kinowksi agreed with Supervisor Young and contended that applying \$1.8 million of Fund Balance is sufficient and that he would not vote for the use of additional Fund Balance.

Supervisor Fagan made a motion to apply \$200,000.00 from Fund Balance, seconded by Supervisor Callery and carried. (Supervisors Breh, Kinowski and Young opposed).

Following the motions regarding Fund Balance appropriations, the Board proceeded to unanimously adopt the 2016 Budget approval resolution.

Upon a motion by Supervisor Callery, seconded by Supervisor Groff and unanimously carried, the Board recessed at 2:15 p.m. until December 14, 2015 at 1:00 p.m.

RESOLVED, That there be, and hereby is, created one (1) Civil Engineer position (Non-Union Job Group A/T-9, 2016 start rate: \$55,176.00, one-year rate: \$64,912.00) in the Planning Department; effective January 1, 2016; and, be it further

WHEREAS, the Superintendent of Highways and Facilities has introduced the goal of developing in-house expertise for maintenance of heating, ventilating and air conditioning systems within county government buildings to eliminate the need for outside maintenance contracts whenever possible; and

WHEREAS, the Superintendent has requested that an existing Maintenance Mechanic position be reclassified to Senior Maintenance Mechanic; and

WHEREAS, at the request of the Superintendent of Highways and Facilities, the Personnel Director has reviewed the job duties and responsibilities of the position and has determined that the title Senior Maintenance Mechanic proposed accurately reflects the duties of said position; now, therefore be it

RESOLVED, That upon the recommendation of the Superintendent of Highways and Facilities, Personnel Director and Committees on Buildings & Grounds/Highway, Personnel and Finance, one (1) Maintenance Mechanic position (Union-Job Group M-12; one year permanent rate of \$18.07 per hour) be and hereby is reclassified to Senior Maintenance Mechanic position (Union-Job Group M-15; one year permanent rate of \$20.55 per hour) in the Highways and Facilities Department, effective January 1, 2016; and, be it further

WHEREAS, Resolution 213 of 2013 authorized a contract with Environmental Design Partnership, LLP (EDP) to prepare a model for Fulton County's "SMART Waters" System; and

WHEREAS, EDP's Findings Report titled, "SMART Waters: A Regional Model for Water and Wastewater Services in Fulton County, NY" concluded that a regional water and wastewater system can be successfully implemented by Fulton County and provide economic benefits for the Region by promoting land development; and

WHEREAS, Resolution 163 of 2014 supported the creation of a regional water and wastewater system in Fulton County and authorized the commencement of discussions with area municipal governments including the City of Gloversville and the Gloversville Board of Water Commissioners; and

WHEREAS, representatives of Fulton County and City of Gloversville officials met periodically for several months to negotiate a Memorandum of Agreement that established a framework of terms and conditions for a formal Inter-municipal Cooperation Agreement that will govern the purchase of excess water capacity by the Fulton County Water and Sewer Agency from the City;

WHEREAS, the aforementioned framework Memorandum of Agreement was approved by the Gloversville Board of Water Commissioners on June 15, 2015; by the Gloversville Common Council on June 27, 2015 and by the Board of Supervisors by Resolution 245, dated July 13, 2015; and

WHEREAS, the formal SMART Waters Inter-municipal Agreement is a monumental example of cooperation between local government officials within the community for the betterment of local residents; now, therefore be it

RESOLVED, That based upon the recommendation of the Committees on Economic Development and Environment, and Finance, the Board of Supervisors hereby approves the SMART Waters Inter-Municipal Agreement as attached hereto and placed on file in the Board of Supervisors Office; and, be it further

WHEREAS, private land owners of said lands (amounting to 263 +/- acres) that could be used for development of a Regional Business Park have petitioned the involved municipalities for annexation of the land into Fulton County from Montgomery County; and

WHEREAS, inasmuch as the envisioned development will benefit the economies of both counties, the county legislative bodies desire to share resulting property tax revenues; now, therefore be it

RESOLVED, That the "Annexation Revenue Sharing Agreement between Fulton and Montgomery Counties regarding Proposed Regional Business Park Site", as attached hereto and made a part hereof, be and hereby is approved including the following key terms and conditions:

- 1. Term of Agreement will be 40 years with automatic renewal for an additional 40 years under the same terms and conditions.
- 2. Fulton County property tax revenue, including Payments in Lieu of Taxes (PILOT), from annexed parcels shall be shared with Montgomery County equally (50% to each)
- 3. Fulton County and Montgomery County shall share equally in all costs associated with environmental and engineering studies to prepare the Park site and in all costs to market the Park Site.
