The Organizational Meeting was called to order by Administrative Officer/Clerk of the Board Jon R. Stead, at 10:00 a.m. Following the Pledge of Allegiance to the Flag, Mr. Stead welcomed everyone and wished everyone a very happy New Year. Mr. Stead stated that the occasion of the Organizational Meeting is a time to reflect on what is going on in our community, our state, our country and around the world. There are still men and women at war defending our Country's system, as a free republic and our rights. He requested that everyone bow their heads in prayer or a moment of silence to honor and remember all the military and government officers working on our behalf to keep America safe and a free country, including our policemen, and our emergency responders.

County Clerk Ann Nickloy was present and asked the Supervisors to rise for administration of the Oath of Office.

Mr. Stead, then acknowledged special guests in attendance: Sheriff Richard Giardino, Assemblyman Marc Butler, Acting District Attorney Chad Brown, Ms. Jennifer Donovan, representing Senator Farley, Matthew Scullin representing Congresswomen Elise Stefanik and Gloversville Mayor Dayton King.

Supervisor Handy then moved for a Republican Caucus. The Board recessed for the Caucus at 10:06 a.m. and reconvened into Regular Session at 10:17 a.m.

Nominations were then made for Temporary Chairman, with Supervisor Waldron nominating Supervisor Kinowski. Supervisor Fagan seconded the nomination. The Clerk then called for other nominations. There being no other nominations, the polls were closed upon a motion by Supervisor Groff, seconded by Supervisor Breh and members voted to support the nomination.

Temporary Chairman Kinowski then asked for nominations for Chairman of the Board for 2016. Supervisor Howard placed the name of Charles Potter, of Gloversville, in nomination for Chairman of the Board.

The motion was seconded by Supervisor Greene. The Temporary Chairman then asked if there were other nominations. The polls were closed upon a motion by Supervisor Argotsinger, seconded by Supervisor Christopher. The motion for Chairman of the Board carried unanimously in the form of Resolution No. 1.

Supervisors Howard and Greene escorted Chairman Potter to the dais.

Chairman Potter said "Thank you" and that he "appreciated and respected the Board's decision" to install him as the 2016 Chairman of the Fulton County Board of Supervisors. Chairman Potter said "Good News is Good News" as he recounted some County initiatives that are underway. "Also, a great deal of thanks to my constituents, Representing the 4th Ward of Gloversville, NY has been rewarding. This past November, I had a record amount of support, truly humbling, these friends of mine really care about the area, I will continue to strive for our goals that we have set. That way everybody wins!"

Chairman Potter took a moment to acknowledge former Chairman of the Board Ralph Ottuso for his "brim and firestone regarding economic initiatives".

Chairman Potter next acknowledged the invited guests in attendance: his fiancé Kayla, "No words can describe the support I receive from her."

He continued by recognizing Matthew Scullin, representing Congresswomen Stefanik. He stated that "all it took was one phone call in 2013 and a bond was formed between the Congresswomen's Office and Fulton County and that bond is unbreakable."

He continued, "Ms. Donovan is from the Northampton area, I believe that's Farley Country! Senator Farley is a great advocate for Fulton County. His experience and saviness works. It works for the Gloversville Library and it works for getting things done. Proven results from a true energetic leader!"

Assemblyman Butler "is a great guy with an unwavering passion for Fulton County residents. Marc stands with us and is very approachable, is very attentive to our needs and very much the kind of leadership we need in a dysfunctional legislature. I know that Marc has never worked in a deli, because he doesn't stand for the bologna that represents the current management in Albany!"

He noted that Judge Louise Sira could not be here because she was in "Judge School". "Louise wishes us well and has been a great District Attorney".

Chairman Potter advised that he is looking forward to working with Sheriff Giardino and his "ideology" and that "he will be great to work with."

Chairman Potter acknowledged his mom, Beth Potter, and followed up by saying "Who doesn't love mom? "Mom's are very important and encouraging."

Chairman Potter then announced "The Chairman's Initiatives as his Compass Point Strategy"; Sherman's Performing Arts Center in the Town of Caroga to promote townships to get sales tax up. In the Town of Mayfield, the Vails Mills Route 30 corridor with the SMART Waters initiatives. The Town of Mayfield will become a "staycation" point. The Town of Northampton will become a vacation destination with the impact of the Northville Placid trailhead there.

Chairman Potter also advised that he would like to see a comprehensive plan for all of Fulton County's Senior Centers.

He further advised that he will be bringing in people and/or businesses that promote our County and have a positive effect on Fulton County.

Lastly, Chairman Potter thanked everyone and advised that "We are leaders moving forward and that it is our time to promote the positive effect for Fulton County".

Chairman Potter then called for nominations for Vice Chairman of the Board for 2016. Supervisor Waldron nominated Supervisor Kinowski noting that he was community-minded and a leader that was fiscally conservative. The motion was seconded by Supervisor Fagan. Chairman Potter then asked if there were other nominations. Supervisor Groff moved that the polls be closed. The motion was seconded by Supervisor Breh and members voted to close the polls.

A vote was held and unanimously approved in the form of Resolution No. 2.

Action was then taken on Resolutions 1 through 12. Chairman Potter distributed the 2016 Standing Committee assignments.

Mr. Stead advised that his office researched that 100 years ago today, on January 4, 1916, Supervisor Harry Steele of the City of Gloversville was elected as Chairman of the Board and today we elected another Chairman from the City of Gloversville.

There being no other business, Supervisor Sullivan moved that the Board adjourn until January 11, 2016 at 1:00 p.m. The motion was seconded by Supervisor Blackmon and unanimously carried. The Board adjourned at 10:34 a.m.
