Chairman Goderie called the meeting to order at 1:00 p.m. Following the Pledge of Allegiance to the Flag, Chairman Goderie asked if there were any public speakers who wished to address the Board. No one came forward.

# PUBLIC HEARINGS/SCHEDULED SPEAKERS

### 1:10 P.M. UNVEILING OF NYSAC CENTENNIAL POSTER

Mr. Stead stated that it is the 100<sup>th</sup> Anniversary of the New York State Association of Counties (NYSAC) formation. At the recent NYSAC Legislative Conference on February 24-26, each county was provided nice wall art commemorating the Anniversary milestone. Mr. Stead turned the attention to the wall of the Board Chambers to present the framed poster which depicts official county seals from all counties in New York State.

# **COMMUNICATIONS**

1. Draft Plan from Community Planning and Environmental Associates dated February 2025 <a href="Subj: Draft of Fulton County Agricultural">Subj: Draft of Fulton County Agricultural</a> and Farmland Protection Plan

Mr. Stead noted the 2023 Proceedings were placed on the Supervisors' chairs prior to the start of the meeting. He noted that Deputy Clerk of the Board Beth Lathers has done many years of those. He stated that it takes a lot of work to complete those books and Ms. Lathers has primary responsibility for all that preparation.

Mr. Stead then stated that there was a Supreme Court decision that was released last week related to the solar farm mandated "appraisal calculator". There were six (6) different counts and the Supreme Court ruled in favor of the Towns in Schoharie County on two (2) of the counts. He stated that it was ruled unconstitutional for how solar farms were mandated to be assessed by the NYS Department of Taxation and Finance. He then stated that NYSAC expects the State to appeal, but he expressed that it appeared to be a "solid" court decision on the two (2) key counts after reviewing it.

### REPORTS OF SPECIAL COMMITTEES

Adirondack Government: Supervisor Palcovic stated that Barbara Rice, Executive Director of the Adirondack Park Agency (APA) was directly involved in the round table meeting. He stated that it was a "first person" point of view, having her there speaking about environmental impacts of solar and the APA's lack of controls on that topic. He also stated that ADA compliance on state trail systems and powered mobility devices is a "huge" topic right now. He stated that there are discussions where they are expanding on state trail systems so handicap individuals can experience the trials.

**Soil and Water Conservation District:** Supervisor Lauria stated that operations are going smooth and the Soil and Water Conservation District Board is hopeful that it's new building will get started this year.

# **CHAIRMAN'S REPORT**

Chairman Goderie stated that he attended the NYSAC event February 24 through February 26, 2025. He expressed that learned "a ton" and strongly encourages anyone who hasn't been to a NYSAC conference to attend in the future. He stated that he sat in multiple seminars: 1) Economic impact on SUNY 2) Hiring and Retention Strategies that explained the NY Helps program 3) NY State Budget Review where Medicaid costs will be increasing 38 percent over 2024. However, the state is predicting a low chance of a recession. He expressed that Fulton County had two successful ice fishing tournaments, which is different from recent years.

# **RESOLUTIONS**

No. 95 (Resolution Setting the Date for a Public Hearing Regarding Adoption of the Fulton County Agricultural and Farmland Protection Plan (2025)): Supervisor Fagan stated that the Agricultural Farmland Protection Board is required to hold a public hearing as well. He stated that it will likely be held on March 26, 2025 at the Planning Department. However, it will be announced when the date and time is finalized.

No. 105 (Resolution Authorizing the Purchase of a New Chevrolet 2500HD Pickup Truck via NYS OGS Vehicle Marketplace (2025 Capital Plan)): Mr. Stead advised that he contacted DeNooyer Chevrolet and they provided a "spec sheet" that confirmed it was a standard model.

A motion was offered by Supervisor Fagan, seconded by Supervisor Young and unanimously carried, to waive the Rules of Order to take action on Late Resolution 1.

No. 110 (Resolution Amending Resolution 60 of 2025 that Awarded a NYS OGS Mini-Bid for a New Dodge Charger Police Patrol Vehicle (PPV)): Mr. Stead explained the NYS OGS mini-bid process from early in the year. He then stated that the Sheriff's Department agreed to accept an older model than a 2025 when it solicited the bids. Mini-bid stated that it is a 2023 left-over Dodge Charger. Dodge did not make the patrol version in 2024 or 2025 and both bidders did bid 2023 models.

# **OLD BUSINESS**

Mr. Stead stated that he is trying to put together a short-term rental unit (STRU) registry working with the County Treasurer. He noted that the Governor did sign the Chapter Amendment on February 28, 2025 that dictates that any STRU registry will be maintained by county government.

He stated that he and Deputy Clerk of the Board Beth Lathers sat-in on different demonstrations of potential software for STRU registry systems. He advised that the new state law allows for a registration fee to help offset the cost to contract with a STRU registration software company if the Board decides to do so. He stated that some towns may be interested in the code enforcement aspect and some of these companies are offering software modules to manage code enforcement for STRU's.

# COUNTY OF FULTON, NEW YORK LOCAL LAW NO. "A" OF 2025

# A LOCAL LAW TO EXTEND THE OCCUPANCY TAX IN FULTON COUNTY AS AUTHORIZED BY ACT OF THE NEW YORK STATE LEGISLATURE (CHAPTER 489 OF THE LAWS OF 2016)

BE IT ENACTED, by the Board of Supervisors of the County of Fulton, New York, as follows:

### Section 1. Title & Statement of Intent.

This local law shall continue to be known as the "Fulton County Occupancy Tax Law". The intent of this local law is to extend the implementation an occupancy tax as authorized by act of Chapter 489 of the Laws of 2016 as enacted by the Fulton County Board of Supervisors in Local Law No. 1 of 2017

# Section 2. Authority.

The authority for this local law is Chapter 489 of the Laws of 2016 of New York State enacted by the Fulton County Board of Supervisors pursuant to Local Law No. 1 of 2017.

### **Section 3. Continuation of Tax.**

The tax established pursuant to Local Law No. 1 of 2017 is hereby continued for an additional three (3) year period.

# Section 4. Separability.

If any provision of this local law or the application thereof to any person or circumstance shall be held invalid, the remainder of this local law and the application of such provision to other persons or circumstances shall not be affected thereby.

#### **Section 29. Effective Date:**

This Local Law shall take effect upon filing with the Secretary of State of New York, except that the provisions of this Local Law relating to registration and the authority of the Treasurer to adopt regulations and take all necessary action to prepare for the implementation and enforcement of this Local Law shall take effect immediately.
