Chairman Argotsinger called the meeting to order at 1:00 p.m. with Supervisors Gendron, Handy and Lauria absent upon roll call. Following the Pledge of Allegiance, Chairman Argotsinger asked if there was anyone from the public who wished to address the Board.

*Jeanette Ryder, Gloversville:* Ms. Ryder advised that she was here on behalf of the Regional Animal Shelter. She stated that she is concerned with a possible duplication of shelter services and buildings by local municipalities. She stated that Nancy Hart, from the Town of Johnstown, has indicated that an organization she is associated with is interested in building an animal shelter on 12 acres of town land located on Maple Avenue. She stated that the Regional Animal Shelter has 26 acres on Maple Avenue that it has already begun work on for a shelter. She indicated that she is concerned that Supervisors were not aware of this effort. She also stated that if the Supervisors were to consider funding for any animal shelter, she hopes they would consider the Regional Animal Shelter first.

### **UPDATES FROM STANDING COMMITTEES**

***Finance:*** Chairman Fagan advised that the Finance Committee reviewed the resolution pertaining to the hiring of a Deputy Sheriff from Albany County. He also thanked the members of the Committee for their efforts this year. He stated that as time goes on, he thinks the job of balancing county finances should get easier, but it doesn't. He stated there are still issues with mandates that make preparing the County Budget very difficult. Chairman Fagan also thanked Mr. Argotsinger for a job well done as Chairman of the Board.

### **REPORTS OF SPECIAL COMMITTEES**

***Fish & Wildlife Board:*** Supervisor Johnson stated that the minutes from the last meeting are on file in the Board Office.

### **CHAIRMAN'S REPORT**

Chairman Argotsinger advised that Fulton Montgomery Regional Chamber of Commerce is hosting a luncheon at the Holiday Inn on Thursday, December 11 at 11:30 a.m. He stated that Ron Peters, President of Fulton County Center for Regional Growth will be addressing plans for the CRG in the coming year. He asked, if possible, for all Supervisors to attend this luncheon.

Chairman Argotsinger thanked everyone for electing him Chairman of the Board for 2014. He stated that it has been an honor to serve as Chairman. He stated that the Chairmanship is very time consuming but he learned a lot. He stated that it is remarkable how much goes on in the County and until you are Chairman, you are not aware of this.

Chairman Argotsinger stated that the goal for the County in 2014 was to reinvigorate economic development and that the County has worked towards that goal. He stated that progress was made on the Tryon Project and that this project has progressed wonderfully in the last few months. He stated that he is very optimistic that the Tryon Project will be a successful venture. He also stated that with regards to SMART Waters, general observers may not have seen a lot of activity; however, there have been meetings with two different entities regarding obtaining water. He stated that progress is being made and that the County will see water to major areas of the county in the future.

Chairman Argotsinger noted the visits from Senators Schumer and Gillibrand in the last couple months and thought that both meetings went very well. He stated that he is optimistic that Fulton County will see some results from their visit with regard to economic development. He stated that you have to always hope for the best even though it is the federal government.

Chairman Argotsinger stated that he is very happy to see the budget adopted with a lower tax rate. With all the projects being done in 2015, he believes the Board did a very good job in approving a budget with a reduced tax rate of 1.5 percent.

Chairman Argotsinger also thanked Mr. Stead and all of the Board Office staff, Budget Director Alice Kuntzsch and County Attorney Jason Brott for their efforts. He wished the the incoming Chairman success for 2015.

Mr. Stead stated that anyone who observed Chairman Argotsinger during the year realizes what a great job he did. He is extremely conscientious about all his duties. He stated that there was a "plethora of meetings" this year and the Chairman kept up with all the activity. He continued that Mr. Argotsinger was a "thoughtful, steady-handed leader" and on behalf of the Board of Supervisors he presented the Chairman with a small token of appreciation in the form of a Dinner Gift Certificate.

WHEREAS, that Section and Article 5 of the County Law is clear that payment for services can only be authorized for those services actually rendered; now, therefore be it
