REPORTS OF SPECIAL COMMITTEES

Fish and Wildlife Board: Supervisor Johnson advised that he left a copy of the February 2015 meeting with the Board of Supervisors Office and it will be placed on file. He also advised that there has been some discussion regarding shortening hunting seasons and the size of deer that can be taken. He stated a public comment period will be held regarding these changes and anyone that is interested can attend. He will let the Board know when this is scheduled.

Inter-County Legislative Committee of the Adirondacks: Supervisor MacVean advised that the February meeting was held at Oak Mountain Ski Center. She stated that the Committee thanked everyone who passed resolutions opposing the State’s economic development “Hunger Games” competition. She also advised that there was a great deal of discussion regarding recreational trails in the Adirondacks and that there should be more trails available that do not include motorized vehicles. She stated there is a push for mountain biking trails, cross country skiing trails, etc.

Soil and Water Conservation District Board: Supervisor Lauria advised that a meeting was held on February 17. He referenced the ongoing projects for Ephratah Rod and Gun Club, Broadalbin Youth Commission, etc . With regards to Johnstown bridge replacement projects, the District Field Manager John Persch is looking into using an oversized culvert with an arch for these projects. If this culvert can be used, it would save the City of Johnstown about \$500,000.00 per bridge. Supervisor Lauria also advised that a grant application has been received. He also advised that spring tree sales are now available if anyone is interested.

CHAIRMAN'S REPORT

Chairman Ottuso advised that a letter was sent to Assemblyman Butler and Senator Farley requesting their attendance at today's meeting. However, due to the Legislature being in session, they were not able to be here.

Chairman Ottuso also advised that the Quote of the Month was, "The time is always right to do the right thing." He noted that this quote was from Martin Luther King. He stated that he received several entries and a name will be drawn and the winner will be announced at the next Board meeting.

LOCAL LAW “A” OF 2015 ENTITLED,
“A LOCAL LAW TO ALLOW CERTAIN “SPARKLING DEVICES” TO BE
EXCLUDED FROM THE DANGEROUS FIREWORKS DEFINITION AS PERMITTED
BY NEW YORK PENAL LAW SECTION 405(b)”

BE ENACTED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF FULTON, AS FOLLOWS:

SECTION 1. INTENT:

The purpose of this Local Law is to allow certain “Sparkling Devices” to be excluded from the dangerous fireworks definition as permitted by New York State Penal Law Section 405(b) in Fulton County.

SECTION 2. DECLARATION OF POLICY:

- A. On November 21, 2014, Governor Cuomo signed into law Chapter 477 of the Laws of 2014 (S.7888/A.10141) that amended the State Penal Law, the Executive Law and the General Business Law placing further restrictions on dangerous fireworks while at the same time recognizing that certain fireworks should not be labeled dangerous when they pose little to no danger to the public. Said state legislation only allows for certain “sparkling devices” to be sold and used in municipalities that affirmatively enact a local law authorizing such.

SECTION 3. DEFINITIONS:

”Sparkling Devices” are defined as follows:

“Sparkling Devices” which are ground-based or hand-held devices that produce a shower of white, gold or colored sparks as their primary pyrotechnic effect. Additional effects may include a colored flame, an audible crackling effect, an audible whistle effect, and smoke. These devices do not rise into the air, do not fire inserts or projectiles into the air, and do not explode or produce a report (an audible crackling-type effect is not considered to be a report). Ground-based or hand-held devices that produce a cloud of smoke as their sole pyrotechnic effect are also included in this category. Types of devices in this category include:

- (1) Cylindrical foundation: cylindrical tube containing not more than seventy-five grams of pyrotechnic composition that may be contained in a different shaped exterior such as a square, rectangle, cylinder or other shape but the interior tubes are cylindrical in shape. Upon ignition, a shower of colored sparks, and sometimes a whistling effect or smoke, is produced. This device may be provided with a spike for insertion into the ground (spike fountain), a wood or plastic base for placing on the ground (base fountain), or a wood or cardboard handle to be hand held (handle fountain). When more than one tube is mounted on a common base, total pyrotechnic composition may not exceed two hundred grams, and when tubes are securely attached to a base and the tubes are separated from each other on the base by a distance of at least half an inch (12.7 millimeters), a maximum total weight of five hundred grams of pyrotechnic composition shall be allowed.
- (2) Cone foundation: cardboard or heavy paper cone containing not more than fifty grams of pyrotechnic composition. The effect is the same as that of a cylindrical fountain. When more than one cone is mounted on a common base, total pyrotechnic composition may not exceed two hundred grams, as is outlined in this subparagraph.
- (3) Wooden sparkler/dipped stick: these devices consist of a wood dowel that has been coated with pyrotechnic composition. Upon ignition of the tip of the device, a shower of sparks is produced. Sparklers may contain up to one hundred grams of pyrotechnic composition per item.
- (4) Novelties which do not require approval from the United States Department of Transportation and are not regulated as explosives, provided that they are manufactured and packaged as described below:

- a) Party popper: small devices with paper or plastic exteriors that are actuated by means of friction (a string or trigger is typically pulled to actuate the device). They frequently resemble champagne bottles or toy pistols in shape. Upon activation, the device expels flame-resistant paper streamers, confetti, or other novelties and produces a small report. Devices may contain not more than sixteen milligrams (0.25 grains) of explosive composition, which is limited to potassium chlorate and red phosphorus. These devices must be packaged in an inner packaging which contains a maximum of seventy-two devices.

- b) Snapper: small, paper-wrapped devices containing not more than one milligram of silver fulminate coated on small bits of sand or gravel. When dropped, the device explodes, producing a small report. Snappers must be in inner packages not to exceed fifty devices each, and the inner packages must contain sawdust or a similar, impact-absorbing material

SECTION 4. SPARKLING DEVICES PERMITTED:

In accordance with Chapter 477 of the Laws of 2014, and Penal Code Section 405, the Board of Supervisors hereby authorizes that “sparkling devices” may be sold and enjoyed in the manner described below, within Fulton County:

1. Sales will only be permitted on or between June 1 through July 5 and December 26 through January 2 of each calendar year.
2. All distributors, manufacturers and retailers must be licensed through the New York State Department of State.
3. Only those persons over the age of 18 may purchase said products.

SECTION 5. SEPARABILITY:

If any part of or provisions of this law, or the application thereof to any person or circumstance, shall be adjudged invalid by any court of competent jurisdiction, such judgment shall be confined in its operation to the part of or provision of, or application directly involved in the controversy in which such the remainder of this law, or the application thereof to other persons or circumstances.

SECTION 6. EFFECTIVE DATE:

This law shall take effect June 1, 2015.
