Chairman Kinowski called the meeting to order at 1:00 p.m. Chairman Kinowski asked if there was anyone from the public who wished to address the Board as public speakers. No one from the public came forward.

Chairman Kinowski then asked for the reading of the Communications on the Agenda.

CHAIRMAN'S REPORT

Chairman Kinowski announced that Dr. Gelman, Public Health Director, was named “2017 Rural Health Champion of the Year” by the Adirondack Health Institute. A round of applause was given.

Chairman Kinowski advised that he went to Washington D.C. two weeks ago to attend a discussion on tax reform at the White House Office of Intergovernmental Affairs. The meeting was attended by about 100 officials. It was a forum made up of mostly small governments from all over the United States. He listened to five or six speakers and found them very interesting.

One of the highlights of the meeting was a visit from Vice-President Michael Pence. He also advised that another speaker was Secretary Sonny Perdue of the Department of Agriculture. Chairman Kinowski advised that he found a presentation by Linda McMahon from the Small Business Administration very interesting because during her speech she said it was important for communities to expand infrastructure. She also emphasized having a strong community college that works with local schools and also having PTECH Schools. He said it was like she was referring to Fulton County because we are doing or have those things here.

Resolutions on the Agenda were then deliberated on.

Chairman Kinowski called for a recess at 1:15 p.m.

Chairman Kinowski then called the meeting back to order at 1:27 p.m.

Mr. Stead, Administrative Officer, explained that Ms. Kuntzsch, Budget Director, had a handout for Board members showing the status of the Tentative 2018 Budget. The average County Tax Rate is \$10.76 per thousand, which is a 7.7 percent increase from last year.

Chairman Kinowski opened the Public Hearing to receive comments regarding the Tentative Budget for the County of Fulton for Fiscal Year Beginning January 1, 2018 at 1:31p.m.

Martin Chevian, East Boulevard, Gloversville, NY - Mr. Chevian sarcastically “thanked” the Board for have the Public Hearing at 1:30 p.m. in the afternoon instead of at night or on the weekend. He explained that he went through the Tentative Budget on-line and specifically mentioned the equipment proposed such as I-pads, desks and desk chairs. He advised that all that equipment could be bought at Wal-Mart or another place at a lower cost. He further advised that using his tax dollars is silly to buy the above mentioned pieces of equipment. He stated “you will buy these items at the lower price”.

Gary Schultz 129 Lake View Avenue, Mayfield, NY – Mr. Schultz explained that the Board needs to look at alternatives for “outside of the box” funding streams. He said that Lake George has a boat registration fee and Fulton County does not. He commented that this would bring money into the County for such things as a full-time dive team. The County could collect registration fees from boaters and this would “bring money into the County”.

He also advised that Fulton County needs a full-time Veterans Director because the part-time Director is never there. He is in Hamilton County or vice-versa.

Chairman Kinowski then commented that the Public Hearing on the Tentative Budget for the County of Fulton for Fiscal Year Beginning January 1, 2018 would remain open until 2:00 p.m. for comments on the Budget.

Chairman Kinowski next called for a budget workshop and asked if any Board members had suggestions for revisions. No suggestions were voiced by Board members.

Chairman Kinowski then called for a recess at 1:39 p.m.

Chairman Kinowski called the meeting back to order at 2:01 p.m.

Chairman Kinowski again asked if there were any members of the public who wished to make comments on the Tentative Budget for the County of Fulton for Fiscal Year Beginning January 1, 2018. There being no interested speakers, Chairman Kinowski closed the Public Hearing at 2:02 p.m.

Chairman Kinowski opened the Public Hearing to receive comments regarding proposed Local Law "I" of 2017 "A Local Law to Amend Local Law 4 of 1985 Relating to the Appointment of Deputies in the Department of Highways and Facilities" at 2:03 p.m. There being no one who wished to speak, the Chairman stated that he would keep the public hearing open.

Resolutions continued to be deliberated on.

At this time, Supervisor Potter asked if he could make a motion on using \$1.3 million dollars in additional fund balance for the 2018 Tentative Budget to get the Budget Levy increase under the mandated Tax Cap. Mr. Stead advised that using \$1.3 million dollars in fund balance would not get the County under the state-mandated Tax Cap. It would require \$1.35 million to achieve that.

Supervisor Potter made a motion to apply an additional \$1,350,000.00 from the Fund Balance, making the new Tax Levy \$28,202,951.00, seconded by Supervisor Fagan. Supervisors Argotsinger, Born, Bradt, Breh, Christopher, Greene, Groff, Howard, Kinowski, Morris, Rice, Waldron, Wilson, Young were opposed. Motion DEFEATED.

Supervisor Callery asked Ms. Kuntzsch what the projected Fund Balance is at this point in time. Ms. Kuntzsch responded that Mr. Blodgett, County Treasurer, would have that projection. Mr. Blodgett was then asked to attend the meeting.

County Treasurer Blodgett came into the meeting and advised that the current Fund Balance for the General Fund is projected at \$16,032,000.00. He also provided balances on the other funds for the County.

Supervisor Waldron asked Mr. Blodgett what is the recommended Fund Balance that should be maintained. Mr. Blodgett explained that the State Comptroller recommends that the County maintain 15 percent of total appropriations in Fund Balance.

Supervisor Howard commented that the Finance Committee has gone over the Budget in several meetings and taking any more funding out of the Fund Balance would not be advisable.

Supervisor Groff advised that the Board "should leave the Tentative Budget right where it is".

Supervisor Young commented that he shared the same concerns as Supervisor Groff and Supervisor Howard and said taking more out of the Fund Balance could put the County into a “fiscal crisis.” It would be “irresponsible” to take more out of the Fund Balance.

Supervisor Born commented that she agreed with all that was said, but there is still the “Raise the Age” coming and the Board should not take any more out of the Fund Balance.

Chairman Kinowski advised that, in his opinion, the Board “should stay where we are” and said “we should be okay”.

Chairman Kinowski again asked if there were any members of the public who wished to make comments regarding proposed Local Law “T” of 2017 “A Local Law to Amend Local Law 4 of 1985 Relating to the Appointment of Deputies in the Department of Highways and Facilities”. There being no interested speakers, Chairman Kinowski closed the Public Hearing at 2:23 p.m.

Chairman Kinowski opened the Public Hearing to receive comments regarding proposed Local Law “H” of 2017 “A Local Law Amending Local Law 1 of 1989 to Create Two Deputy Positions at the Department of Solid Waste” at 2:24 p.m. There being no one who wished to speak, the Chairman stated that he would keep the public hearing open.

Chairman Kinowski then called for a five minute recess at 2:26 p.m.

Chairman Kinowski called the meeting back to order at 2:34 p.m.

Chairman Kinowski again asked if there were any members of the public who wished to make comments regarding proposed Local Law “H” of 2017 “A Local Law Amending Local Law 1 of 1989 to Create Two Deputy Positions at the Department of Solid Waste”. There being no interested speakers, Chairman Kinowski closed the Public Hearing at 2:35 p.m.

Mr. Stead announced that the next Board Meeting will be held on December 11, 2017, and there will be a Finance Committee Meeting prior to it that morning. A meeting notice will be mailed out for both meetings.

**LOCAL LAW 7 OF 2017
AMENDING LOCAL LAW 4 OF 1985
RELATING TO THE APPOINTMENT OF DEPUTIES”**

Now, therefore be it enacted

Purpose: To amend the Local Law creating the Fulton County Department of Highways and Facilities to revise the appointing authority for Deputies.

Chapter 92, Highways and Facilities Department, shall be amended as follows:

Section 92-4. Powers and Duties of Superintendent:

Paragraph D:

DELETE: Paragraph in its entirety

AND REPLACE WITH:

D. In accordance with provisions of §102-a of the New York State Highway Law, the Fulton County Superintendent of Highways and Facilities shall have the power and sole authority to appoint and remove subordinate employees within his/her department, including the appointment of the Deputy Highway Superintendent and the Deputy Superintendent of Facilities.

Section 92-5. Deputies.

ADD: “and Fulton County Deputy Superintendent of Facilities” at the end of the first sentence.

Paragraph A. Appointment.

DELETE: Subparagraph 1) in its entirety

AND REPLACE WITH: “There shall be a Deputy Highway Superintendent and a Deputy Superintendent of Facilities who shall be appointed by the Superintendent of Highways and Facilities.”

Paragraph C. Qualifications.:

Subparagraph 1)

DELETE: Deputy Superintendent of Highways

AND REPLACE WITH: Deputy Highway Superintendent

Paragraph D. Powers and duties.:

DELETE: The paragraph in its entirety

AND REPLACE WITH: The Deputy Highway Superintendent and the Deputy Superintendent of Facilities shall act generally for and in place of the Superintendent of Highways and Facilities and when acting in such capacity shall have the powers and authorities of the Superintendent in their respective units of the Highways and Facilities Department.

Section 92-7. Implementation of Procedures:

DELETE: “Highway and Buildings and Grounds Departments” in the first sentence.

AND REPLACE WITH: Department of Highways and Facilities

Paragraph A.:

DELETE: “or Superintendent of Buildings and Grounds”

AND REPLACE WITH: “and Facilities”

Purpose: The purpose of this Local Law is to amend Chapter 169 of the Fulton County Code to abolish the position of Deputy Director of Solid Waste Management and create the positions of Deputy Director of Solid Waste (Operations) and Deputy Director of Solid Waste (Administration) within the Fulton County Department of Solid Waste.

Chapter 169: Solid Waste Department, shall be amended as follows:

AND REPLACE WITH: “Deputy Director of Solid Waste (Operations) and the Deputy Director of Solid Waste (Administration) at his/her pleasure”

Paragraph C.

DELETE: “Deputy Director of Solid Waste Management”

AND REPLACE WITH: “Deputy Director of Solid Waste (Operations) and Deputy Director of Solid Waste (Administration)

ADD: “in their respective functions of Operations and Administration” at the end of the sentence.
